# BUILDING REHABILITATION APPEALS BOARD

At this point in time the City Council adjourned and sat as the Building Rehabilitation Appeals Board.

3. BOARD OF APPEALS HEARING FOR PROPERTIES LOCATED AT 8223 W. NORTON AVE.: Bob Harvey, Building and Safety, gave the staff report. ACTION: The Building Rehabilitation Appeals

Board finds that the property located at 8223 W. Avenue is substandard, and orders the property owner to abate all substandard conditions on the property by repairing and maintaining the property in a safe and habitable condition. Further, the Building Rehabilitation Appeals Board orders that all such work be completed on or before February 6, 1991, and if not completed, that the City demolish the dwelling and any other structures or improvements located on the property, clear the property of all debris, and fence the property to avoid unauthorized entry. Adopt Resolution No. 798, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, ACTING AS THE BUILDING REHABILITATION APPEALS BOARD, DECLARING THE CONDITION OF THE PROPERTY AND STRUCTURE LOCATED AT 8223 WEST NORTON, WEST HOLLYWOOD, CALIFORNIA TO BE PUBLIC NUISANCE AND ORDERING THE ABATEMENT Motion Land second Koretz. Hearing no NUISANCE. objection it was so ordered.

## PUBLIC HEARINGS

4. APPEAL OF THE PLANNING COMMISSION'S APPROVAL OF DEMOLITION PERMIT 90-23, DEVELOPMENT PERMIT 90-29 AND NEGATIVE DECLARATION 90-17, ON APPLICATION OF THE COMMUNITY HOUSING CORP. (1256-60 N. HARPER AVE.): The staff report was given by Bill Meeker. The City Clerk reported that this appeal was published in the Post Newspaper and posted at City Hall and the 3 required places. Mayor Heilman opened the public hearing and the following persons came forward to address the Council:

Larry Nicholas, representing the appellant - (5 minutes) - not against the project; concern with environment; concern for parking on Harper; concern with it happening quickly; concern with the 40 trees on the lot. Neighborhood wants construction delayed for a period of one year.

Dhona Spacinsky, appellant - (3 minutes) - Housing Corporation has just completed a project - have been in the middle of construction for the past three years, causing stress and disruption in the neighborhood.

Blaine Hower, West Hollywood - environmental issue not AIDS issue.

Carrie Evans and Gary Goldstein - Trees and wildlife concerns.

Ellen Dubin, West Hollywood - People with AIDS in need of housing can't wait a year.

Dierdre Hays, West Hollywood - in favor of project.

Tony Arn, West Hollywood - in favor of project.

Helen Albert, West Hollywood - in favor of project. Udana Power, West Hollywood - concerned about choice of site. Lack of parking.

Kim Kralj, West Hollywood - in favor of project.

James Dowling, West Hollywood - in favor of project.

Dale Griner, Act-Up Los Angeles - in favor of project.

Stewart Bailey, West Hollywood - signed petitions because false information. In favor of project.

Rodney Scott, West Hollywood - opposed to delay; in favor of project.

Walt Hanna, Exec. Director of Aid for AIDS - in favor of project.

Bruce Farwell, - in favor of project.

Joyce Canham, L. A. - in favor of project, no delays.

David Etezadi, Community Housing Corp. - In favor project.

Marla Baklin, Board of Directors, Community Housing Corp. support the project.

Mike Radcliffe, West Hollywood - support the project, have been built sooner - do not delay.

Rebecca Loque, Board of Directors, Community Housing Corp. need this housing now, can't wait another year.

Sean Kinney, Being Alive - support for the project.

Mark Handley, West Hollywood - misled and signed petition. In favor of project.

Lenore Hudson, West Hollywood - live next door to the project.

Dakota Sands, West Hollywood - support of proceeding now. Bruce Mirken, West Hollywood - Deny the appeal.

Michael Reynolds, West Hollywood Cares - Deny the appeal. Jack Allendorfer, West Hollywood - in favor of project.

Stan Lothridge, West Hollywood - Will disabled seniors allowed? Buy and rehab an existing facility.

Ernie Over, West Hollywood - deny the appeal - need this housing now.

Charles Elsesser, Housing advisor for Sen. Roberti for the project and for the Housing Corporation.

Michaeljohn Horne, West Hollywood - deny the appeal, the project.

Lauren Leary, West Hollywood - deny the appeal. Richard Iosty, West Hollywood - against the appeal. Tom Flynn, West Hollywood - works nights, can't sleep. Corint Roberts, West Hollywood - in favor of project.

Paul Zimmerman, Ex. Director, Community Housing Corp. rebuttal - request to deny the appeal and allow construction to proceed. Include a construction management plan. Hope to have 29 spaces for 22 units for parking.

Sal Lucarillo - Wendall Jones, Venice - getting more homeless from West Hollywood at the homeless center. Richard Gray, West Hollywood - support the project.

Dhona Spacinsky, appellant - rebuttal - asking for one-year delay.

No one else coming forward to speak, Mayor Heilman closed the public hearing and returned this item to the Council for discussion and action.

ACTION: Deny the appeal and adopt Resolution No. 799, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, APPROVING DEMOLITION PERMIT 90-23, DEVELOPMENT PERMIT 90-29 AND NEGATIVE DECLARATION 90-17, ON APPLICATION OF THE WEST HOLLYWOOD COMMUNITY HOUSING CORPORATION, TO DEMOLISH THREE RESIDENTIAL UNITS AND AN OUTBUILDING AND TO CONSTRUCT TWENTY-TWO APARTMENT UNITS FOR OCCUPANCY BY PERSONS WITH AIDS AND/OR DISABLED SENIOR CITIZENS, ON PROPERTY LOCATED AT 1256-60 N. HARPER AVENUE, WEST HOLLYWOOD, CALIFORNIA.

## NEW BUSINESS

**5-A. WAR IN PERSIAN GULF - RESOLUTION:** The report was given by Councilmember Lang. The following persons came forward to address the Council on this item:

Mike Radcliffe, West Hollywood - want resolution supporting the troops.

Stan Lothridge, West Hollywood - opposed to resolution. Put flag on front of City Hall.

Bruce Mirken, West Hollywood - support but it's too weak.

Ralph Feeley, West Hollywood - opposed to resolution.

Budd Kops, West Hollywood - opposed to resolution - support the troops.

Michael Sidler, West Hollywood - wants conflict to end.

Tony Arn, West Hollywood - support resolution but it's too weak - supports the troops and their right to live.

Rev. John Von Douris, West Hollywood - time for country to pull together - support the troops.

Jeanne Dobrin, West Hollywood - everyone wants peace.

Councilmember Guarriello stated that if this had been done before the conflict started he would have supported it, but now he wants full support for the troops.

Mayor Heilman stated that there was nothing in this resolution that was not in support of our troops, it is only urging the President to continue to pursue peace and bring our troops home. He asked to add before the last Resolved:

Be it further resolved that the City of West Hollywood expresses deep concern and compassion for the men and women who are fighting on the front lines and desires to express our full support for those people who are involved in this conflict. ACTION: To approve and adopt Resolution No. 800, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD URGING THE PRESIDENT OF THE UNITED STATES OF AMERICA TO USE PEACEFUL MEANS TO BRING THE WAR IN THE PERSIAN GULF TO A RAPID CONCLUSION," with Mayor Heilman's added language. Motion Koretz second Land.

FIVE-YEAR REVENUE AND EXPENDITURE PROJECTION: The report was given by Asst. City Manager Edgerly, Director of Administrative Services, Kay Jimno, and Finance Officer Paul Arevalo. Mayor Heilman asked if the Proposition C funds that the City would receive would be factored in, and asked about the special funds. Mr. Arevalo stated that this document was set up as an ongoing expenditure budget. Councilmember Guarriello asked about freezing the funded grant programs. Councilmember Lang stated that funds should be allotted to keep up the infrastructure (sewers, streets, etc.) The following persons came forward to address the Council: Michael Sidler, West Hollywood -Bruce Traub, West Hollywood - property tax revenue and interest rates on investments. Councilmember Land stated that staff should look at ways to

Councilmember Land stated that staff should look at ways to save money; use of consultants; hiring freezes and lay-off policies; look at strategic planning areas; EPA requirements; sharing services with adjacent cities; investigate grant specialists.

COUNCILMEMBERS COMMENTS: This time has been set aside for the Councilmembers to direct comments to staff and/or the public on any and all matters of interest. Mayor Heilman asked the Ass't. City Manager to investigate Kings Croissant and Tex Mex complaints.

City Attorney Jenkins reported on the median strip acquisition.

#### LEGISLATIVE

7. PARKING RESTRICTIONS IN PREFERENTIAL PARKING DISTRICTS: THIS ITEM WAS HEARD IMMEDIATELY FOLLOWING THE CONSENT CALENDAR BUT IS LISTED HERE FOR CLARITY. This amendment would allow real estate agents conducting open houses up to five one-day residential parking permits. ACTION: Introduce on first reading, Ordinance No. 283, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD AMENDING THE PARKING RESTRICTIONS IN PREFERENTIAL PARKING DISTRICTS AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE." Motion Land second Guarriello. Hearing no objection it was so ordered.
