#### **NEW BUSINESS**

12. 1106 LA CIENEGA, TANDEM PARKING: John Jacupcek gave the staff report. The following persons addressed the Council: Jeff Lambert addressed the Council as the representative of the owner.

ACTION: Approve the tandem parking request as proposed, for 85 parking spaces with spaces #56, 63 and 64 <u>not</u> considered as approved parking spaces and requiring two free hours of validated parking for customers of the businesses and the option for customers to self-park in the prime spaces without charge. Motion Lang, second Koretz. Hearing no objection it was so ordered.

Hogan stated that appeals from the Business License Commission are generally held on the record but this appeal appears to raise issues not heard and if the Council wishes to hear the whole appeal they should direct the Director of Community Development to hold a pre-hearing review of any evidence which is proposed to be brought before this Council and the reasons why it could not be heard previously. She stated that it was her understanding that not only does the appeal raise certain issues, but other facts have come up since the hearing to which people want to propose evidence.
