CALL TO ORDER: Mayor Heilman called the meeting to order at 6:35 p.m. and adjourned to a closed session to discuss matters pertaining to personnel and potential and pending litigation. Present were Mayor Heilman and Councilmembers Lang and Guarriello. Councilmember Land and Mayor pro-tempore Koretz arrived at 6:45 p.m.

The meeting was reconvened at 7:10 p.m.

APPROVAL OF AGENDA: Mayor Heilman pulled 2c and 2f for separate discussion.

Congratulations were extended to Jeanne Dobrin on her birthday by the Council and the audience. A cake was provided for everyone's enjoyment.

CITIZEN COMMENTS - 15 MINUTES: This time has been set aside for the public to address the City Council on matters of importance, on or off the agenda. Citizen comments will also be heard at the end of the meeting. The following addressed the Council:

Carter Braymann - interested in opening a cafe on Santa Monica Boulevard - problems with parking requirements.

Mike Bygrave, West Hollywood - N. Sweetzer - amendment to require 15' easements between commercial and residential and clarify the definition of residential property.

Shem Schroeck, West Hollywood - support of amendment. Eleanor George, West Hollywood - support of amendment.

Franklin Cover, support of amendment.

Mike Radcliff, West Hollywood - Homeless shelter.

Michael Sidler, West Hollywood - early intervention a cure for violence.

David Enos, West Hollywood - require Cultural Heritage Advisory Board to allow affected property owners to speak at their meetings.

Roselyn Krause, West Hollywood - swimming pool, request to remain

open until November 16. Presented petition with 29 signatures. Tad Bright, West Hollywood - changes in Brown Act. Jeanne Dobrin, West Hollywood - changes in Brown Act. Ed Riney, West Hollywood - Homeless shelter - Ordinance against people living in cars.

- f. Ordinance Changing Certain Violations from Misdemeanors to Infractions: REMOVED FOR SEPARATE DISCUSSION BUT LISTED HERE FOR CLARITY. Ed Riney spoke in favor of this item. ACTION: To waive further reading and adopt on second reading Ordinance No. 270, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD RELATING TO PENALTIES FOR VIOLATION OF CERTAIN MUNICIPAL CODE PROVISIONS AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE." Motion Land second Guarriello. Hearing no objection it was so ordered.
- g. Award of Sealed Bid for Signage for Parking Districts #1 and #5: ACTION: That Council award the bid for the purchase of signage in the amount of \$9,044.67 to Central Cities Sign Service.

- h. Resolution Authorizing Mayor's Signature of Easement Deeds: ACTION: To approve and adopt Resolution No. 736, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD AUTHORIZING THE EXECUTION OF EASEMENT DEEDS." Approved as part of the Consent Calendar.
- 3. WORKSHOP ON PROPOSED ZONING ORDINANCE: This time is set aside for Council review and discussion of the proposed West Hollywood Zoning Ordinance. Mark Winogrond, Director of Community Development, gave an overview of the changes and differences in the proposed ordinance, and suggested that the Council proceed by taking each member's items of concerns, a section at a time.

Mayor Heilman asked questions about Section 9116, Determination of Permitted Uses, and 9118, Conflict With Other Regulations - Mark Winogrond stated that the City looked to the most restrictive. Mayor Heilman felt that all codes should be made consistant and asked for comments and suggestions from Mr. Winogrond before the next workshop.

Section 9120, Enforcement - study session in the future to discuss Code Enforcement and Building and Safety enforcement and what the Council would like to see happen.

Section 9214, Permitted Uses - correction of a typo in A; questions about artist lofts in C; Dormitories in I; Garage Sales in K - delete "to be conducted only within the garage or rear yard"; Hotels - corrected 2d to read O(1); Legalization of Residential Units - staff to report back on relocation benefits for non-rent controlled units and bring back language on an amnesty period for bootlegs and ways to require that they be brought up to Building and Safety Codes; Home Occupations in N, think about employees and discuss later.

9215, General Building Standards - A, R2, 2, add "lot" at end of 3rd line; B, R3B, R3C and R4 - #3, "within the same zone" - want to get Planning Commission input and diagrams and a couple of scenarios from Mr. Winogrond, for further consideration; R-4 - #4, "low and moderate income" - should be consistent with R3B and R3C and need staff to prepare language to include middle-income persons as well - delete older as should cover other congregate housing such as people with disabilities and AIDS. Mr. Winogrond to bring back proper language for consideration. 2e, Narrow Lots Staff to return with - should read "Where a lot or parcel". diagrams of lot types (key lots, reverse corner lots, etc.) the next session. 9221, Purpose - should read, "ground floor commercial space limited to those uses and designs likely to generate...". 9224, Permitted Uses - O, Consumer Repair Services, concern about toxic materials used in furniture repair; U, General Retail Services, add bookstores, except those regulated by 9224B; X, Health Club, Spa, staff bring language for dance studios; Outdoor dining areas, add new category/conditions requiring a Conditional Use Permit for those adjacent to resineighborhoods and permit all others. COUNCILMEMBERS COMMENTS: This time has been set aside for the Councilmembers to direct comments to staff and/or the public on any and all matters of interest.

Councilmember Guarriello wants question of the pool settled.

Councilmembers would like to see it stay open until November 16th if the City can meet the rehab. schedule.

Councilmember Lang stated that they are attempting to make contact with women who voted in 1920, on the 70th anniversary of Women's suffrage.

Councilmember Land asked about occupancy standards and how they were coordinated with the Fire Department. She also announced that the West Hollywood swim team had won at least 2 gold medals at the Olympics.

Councilmember Koretz stated that the City would continue to

function in the same manner as in the past, until the legislature cleans up their recent actions nulifying parts of the Brown Act.

ADJOURNMENT The meeting was adjourned at 9:40 p.m. in memory of Robert Alex, to a regular adjourned meeting on September 4, 1990, at 6:00 p.m. for a closed session, 6:30 p.m. for a study session, and 7:00 p.m. for the meeting at West Hollywood Park Auditorium.
