3. LANDSCAPE MAINTENANCE DISTRICT NO. 1: The City Clerk reported that this item was noticed in the Post Newspaper and posted at Plummer Park, the San Vicente Library, the Sheriff's Station and City Hall. The staff report was given by Cyndy Holtz. Mayor Heilman opened the public hearing. No one coming forward to speak, Mayor Heilman closed the public hearing and returned this item to the Council for discussion.

ACTION: Adopt Resolution No. 716, "A RESOLUTION OF THE CITY

COUNCIL OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, CONFIRMING THE DIAGRAM AND ASSESSMENT, ORDERING THE IMPROVEMENTS IN CONNECTION WITH LANDSCAPE MAINTENANCE DISTRICT NO. 1 AND APPROVING THE ENGINEER'S REPORT." Motion Guarriello second Koretz. Hearing no objection it was so ordered.

4. EXTENDING THE MORATORIUM ON PERMIT REVIEW AND ISSUANCE FOR BETTY WAY: The City Clerk reported that this item was noticed in the Post Newspaper and posted at Plummer Park, the San Vicente Library, the Sheriff's Station and City Hall. The staff report was given by Anne Browning. Mayor Heilman opened the public hearing. No one coming forward to speak, Mayor Heilman closed the public hearing and returned this item to the Council for discussion.

ACTION: Adopt Ordinance No. 268U, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD EXTENDING ORDINANCE NO. 259U AND DECLARING THE URGENCY THEREOF", the Ordinance extending the moratorium on Betty Way until such time as the Design Guidelines for Betty Way are adopted. Motion Land second Lang. Hearing no objection it was so ordered.

COUNCILMEMBERS COMMENTS: This time has been set aside for the Councilmembers to direct comments to staff and/or the public on any and all matters of interest.

Councilmember Lang asked staff for information on why the Business License Commission has not held hearings on Bar 1. Direction was given to staff to take enforcement action as they are operating illegally without a license.

UNFINISHED BUSINESS

5. ADOPTION OF BUDGET: Councilmember Guarriello requested an itemized situation from January to June showing where the money was spent. Direction was given to staff to provide this information.

Ed Riney addressed the Council at this time, requesting that the money for the Homeless Shelter be cut from the budget. ACTION: Adopt the West Hollywood Budget for Fiscal Year 1990-91 - Resolution No. 718. Motion Lang second Land. Hearing no objection it was so ordered.

Councilmember Koretz requested information on the request of the Schindler House for funds. This report will be returned to the Council at the first meeting of August.

Councilmember Land requested a breakdown from the Sheriff's Department on where and when the foot patrols are operating.

NEW BUSINESS

6. REVIEW OF SUNSET BOULEVARD SPECIFIC PLAN WORK PROGRAM AND APPOINTMENT OF ADVISORY GROUP MEMBERS: The staff report was given by Anne Browning.

Charlie Mercer, Sunset Strip Association, addressed the Council on this item.

ACTION: That the Draft work program be approved (3 main components; design, economics and infrastructure), with the following additions: Make sure there is representation from Chamber subcommittee; the Restaurant/Nightclub subcommittee, if it is still in existence; members of the Sunset Task Force; the Marketing Corporation; and the Housing Corporation. Coordinate this plan with the Strategic Plan, our economic development activities and also our concerns promote jobs and housing balance. Need to resolve how to choose the Advisory Board ask the organizations to give the Council a couple of names of persons who wish to serve and then the Council will approve the Board in 2 weeks. Motion Land second Lang. Hearing no objection it was so ordered.

7. RESOLUTION ON ZIP CODES: ACTION:

- 1. Approve Resolution No.717, "A RESOLUTION OF THE CITY OF WEST HOLLYWOOD URGING THE UNITED STATES CONGRESS TO ENDORSE HOUSE RESOLUTION 2380 AND SENATE BILL 1214 RELATING TO THE REDRAWING OF ZIP CODE BOUNDARIES."
- Direct staff to monitor movement of current bills in congress;
- 3. Direct staff to prepare letters to all members of Congress, the Government Accounting Office and the National League of Cities, indicating this City's strong support for H.R. 2380 and S. 1214;
- 4. Send letters on this issue from the City Council to selected members of legislative bodies and members of the appropriate committees;
- 5. Direct staff to develop a postcard to be submitted to residents in the forthcoming issue of "City News," to provide public testimony concerning the problems individuals are experiencing because of the cross-jurisdictional ZIP code system; and

6. Direct the City's lobbyists to work on this issue in Sacramento with legislators, to encourage them to assume leadership regarding the ZIP code problem.

Motion Land second Koretz. Hearing no objection it was so ordered.

8. BUSINESS LICENSE ORDINANCE: ACTION: To introduce on first reading, Ordinance No. 269, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD RELATING TO BUSINESS REGISTRATION AND LICENSING AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE." Motion Koretz second Land.
