3. AMENDMENTS TO CHAPTER 96 OF MUNICIPAL CODE FOR THE PURPOSE OF MODIFYING THE PROCEDURE AND TIMING FOR REDUCING EARTHQUAKE HAZARDS IN UNREINFORCED MASONRY BUILDINGS AND A DISCUSSION OF FINANCING OPTIONS, AND AMENDMENTS TO THE RENT STABILIZATION ORDINANCE AS THEY RELATE TO SEISMIC REHABILITATION: Mark Winogrond, Director of Community Development, gave the staff report. The Deputy City Clerk reported on noticing and posting and Debbie Potter, Community Development Department, reported that a full report was mailed to 82 owners of potentially hazardous buildings.

- 2) Instruct staff to prepare the required resolution to waive only seismic-retrofitting-related building permit fees for commercial and residential buildings that comply with full strengthening requirements within three years from the date of the official notification, and direct Willdan to bill the City on an hourly basis for all URM building inspections;
- Approve the following amendments to the Rent Stabilization Ordinance and instruct staff to prepare the required text amendments and return to the Rent Stabilization Commission and City Council for final approval: a) create a 30-year amortization schedule for seismic rehabilitation; b) allow rent increases in excess of 50 percent to be spread over a three-year period for seismic rehabiliation; c) Streamline the rent increase application procedure for seismic retrofitting; d) create a tenant benefits section that will address relocation

compensation; and e) waive rent increase application fees for seismic retrofitting;

4) Approve and adopt Resolution No. 676, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD APPROVING THE MITIGATED NEGATIVE DECLARATION PREPARED IN CONNECTION WITH ORDINANCE NO. 254, AMENDMENTS TO CHAPTER 96 OF THE WEST HOLLYWOOD MUNICIPAL CODE RELATING TO REDUCING EARTHQUAKE HAZARDS IN UNREINFORCED MASONRY BUILDINGS", and Monitoring Plan (Exhibit F) for the Mitigated Negative Declaration.

Adopt Resolution No. 678, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD APPROVING TEMPORARY USE PERMIT 89-25 ON AN APPLICATION OF CEDARS-SINAI MEDICAL CENTER FOR A TEMPORARY PARKING LOT AT 365 NORTH SAN VICENTE BOULEVARD, WEST HOLLYWOOD", with the hours as requested but no entry after 6:00 p.m. The Transportation Department was directed to conduct a traffic survey to see what restrictions need to be made, with the applicant to pay for mitigation measures, including any signage. Cedars to work with the City Environmental staff to create carpooling and signs should specify no excessive idling in the parking lot. Motion Heilman second Koretz.

- **6. CHANGE OF USE POLICY REPORT:** The staff report was given by Debbie Potter. Grafton Tanquary addressed the Council on this item. ACTION:
 - 1) Approve deleting the change of use section in the Rent Stabilization Ordinance (RSO) and instruct staff to prepare the necessary amendments to the RSO and return to the Rent Stabilization Commission and City Council for final approval;
 - 2) Approve adding provisions equivalent to Section 9224(B)10 of the Zoning Ordinance to all other zones in the City. Section 9224(B)10 regulates the conversion of residential rental housing to common interest developments or to any other use in RHD zones. New

language would include the findings and conversion categories contained in this report. Instruct staff to prepare the necessary amendments to the Zoning Ordinance and return to the Planning Commission and City Council for final approval;

- 3) Instruct staff to prepare a fee schedule for projects requiring a C.U.P. to change from residential rental property to any other use and return to City Council for final approval; and
- 4) Approve adding a section to the RSO that would address the issue of reduction in residential rental units and instruct staff to prepare the necessary amendments to the RSO and return to the Rent Stabilization Commission and City Council for final approval.

Also, that all amendments go into effect at the same time to ensure continued regulatory coverage for conversion to non-rental uses and reduction in rental units.

Motion Heilman second Albert. Hearing no objection and noting the absence of Koretz and Schulte it was so ordered.
