3. IMPLEMENTATION OF TWO-HOUR, NON-PERMIT TIME ZONE IN PREFERENTIAL PARKING DISTRICT 5: The City Clerk reported that this hearing was advertised in the Post Newspaper and posted in the three required places plus at City Hall. Elizabeth Atwell reported that staff recommends the adoption of a two-hour, non-permit time zone (7:00 p.m. to 9:00 p.m., every day) on both sides of Cynthia St. between Doheny Drive and San Vicente Blvd., requiring an amendment to the Preferential Parking Ordinance. Mayor Land opened the public hearing and the following persons came forward to address the

Motion Heilman second Schulte. Hearing no objection it was so ordered. FURTHER ACTION: The Council requested a 6 months review of the parking change and referred to staff and the Parking Task Force to redesign the signs and report on a tow-away zone.

4. Anne Browning gave the staff report, recommending that the Council approve the Ordinance with the changes outlined in the section on staff analysis in this report. Gene Smith spoke for the Planning Commission, recommending a separate Board or Commission, not an added duty for the Planning Commission. Mayor Land opened the public hearing and the following persons came forward to address the Council on this item:

No one else coming forward to speak, this item was returned to Council for discussion. Additional information was requested on "personnel financial difficulties", State funding regulations, Board or Commission vs. Planning Commission, CEQA approval, special provisions for non-profit and religious organizations, small owners requirements, designation process, effect on commercial enterprises such as Warner Studios and Sunset Plaza, strengthening of language on criteria, tightening language on demolitions, and options to provide people with needed resources.

ACTION: Continue the Public Hearing open to the meeting of October 2, 1989. By consensus of the Council.

At this point in time Sally Fisher gave a Hunger Strike report and thanked the City Council for their assistance.

Mayor Land called a recess at 9:41 P.M. The meeting reconvened at 9:50 P.M.

Mayor Land announced that Items 14 and 11 would be moved forward and heard following Item 8.

BUILDING REHABILITATION APPEALS BOARD

5. BOARD OF APPEALS HEARING FOR PROPERTIES LOCATED AT 1216 N. LA BREA AVENUE: Bob Harvey, Building and Safety Department, gave the staff report. The following persons came forward to address the Council on this issue:

Earle Adams, West Hollywood Dr. Hilton Cutler, West Hollywood Dr. Frank F. Cutler, West Hollywood Mrs. Lucille Ristuccia, Hemet - Owner of the property.

City Council discussion ensued concerning the on-going problems the City has had with this property.

ACTION: That the Building Rehabilitation Appeals Board find the property substandard, declare it a public nuisance, and order that repairs be done by October 10, 1989, or the buildings be demolished. The fencing is to be maintained, the lots to be kept clear of debris. City staff is authorized to go on the property, make the needed repairs or demolition and place a lien on the property for the cost of such repairs or demolition. Motion Schulte second Heilman.

Directions were given to staff to assist the adjoining property owners to gain access for repairs necessitated by a fire on the subject property.

COUNCILMEMBERS COMMENTS: This time has been set aside for the Councilmembers to direct comments to staff and/or the public on any and all matters of interest.

Councilmember Koretz would like Human Services Department to return to Council with a report on crime in the parks. Councilmember Heilman replied that a task force is meeting and will bring back recommendations. He also stated that the handicapped would qualify for the Jewish Family Service Food Program and it would better accommodate their needs. Councilmember Koretz reminded everyone that it is Pet Awareness Week and there would be a pet parade on Sunday in Plummer Park. Councilmember Schulte asked staff to set up a study session with the Council and the Rent Stabilization Board. He also requested that the Human Services Department look at the criteria for when homeless/mentally ill are at risk to themselves and how long people can be held for observation, and return to Council in 30 days with a report. At that time the City should contact its lobbyist in Sacramento and try to get co-sponsors for needed legislation. Councilmember Albert announced the Beau Arts Festival next weekend. Councilmember Heilman asked if there were activities in October for AIDS Awareness Month and if the changed attitudes on testing could be included. Mayor Land requested a study session on City investments and our policies along with the Rent Stabilization session in October or November. She further requested information on the requirement for house numbering and business numbering and a report on Palette Restaurant.

UNFINISHED BUSINESS

6. GLASS WILTON GROUP HOME: Jodi Curlee gave the staff report. Dan Gumbleton, GLASS, requested support. Councilmember Heilman expressed the City's frustration at the delay in GLASS projects. ACTION: That City Council extend the time of performance of the GLASS Wilton Group Home contract to February 28, 1990. Motion Schulte second Koretz. Hearing no objection it was so ordered.

7. SUNSET BOULEVARD TRAFFIC STUDY (CIP #835): Chuck Bergsen, Director of Public Works, gave the staff report. The following persons came forward to address the Council on this item:

Council discussion followed and Councilmember Heilman requested that staff meet with Tower Records management to work out solutions. He stated that he also has concerns with the safety of crosswalks on Sunset on non-signal intersections. Mayor Land had questions on the number of parking spaces on page 9, and requested a timeline on when these various things will happen. ACTION: That City Council review and adopt the recommendations of the Transportation Commission and its Subcommittee and direct the Department of Public Works to implement those recommendations. Motion Schulte second Albert. Hearing no objection it was so ordered.

8. FINAL SOCIAL SERVICES FUNDING YEAR 1989-90 CONTRACT EXTENSIONS AND MERIT INCREASES: Staff report was given by Jodi Curlee. Paul Self, Executive Director from Aid for AIDS addressed the Council. ACTION:

1) Approve Exhibit 1 (Attachment A) as boilerplate to extend social services contracts to September 30, 1990 and direct staff to negotiate budgets and Exhibit A's and otherwise implement extensions of current social services contracts to September 30, 1990;

contracts to September 30, 1990;
 2) Approve 1989-90 Social Services funding allocations
including merit increases as summarized in Attachment B for
the period October 1, 1989 through September 30, 1990;

3) Approve Aid for AIDS for \$80,860 and direct staff to decrease its goals proportionately to the reduction in supplemental funding;

4) Authorize staff to change GLCSC Legal's Exhibit A and Budget by reducing consultation and referral goals, adding a community education project, and adding the development and distribution of a "Know Your Rights" brochure and legal resource list for the entire West Hollywood community.

5) Approve CORE for \$36,383 (includes 5% merit increase) plus \$5,940 in AIDS education funds for a total of \$42,323 with a corresponding increase in goals and negotiate to target street youth for materials distribution.

6) Direct staff to return with recommendations for spending of AIDS supplemental funding (\$19,800) and savings in merit increase recommendations (\$8,904). Motion Heilman second Schulte. Hearing no objection it was so ordered.

9. STATUTORY ENTITLEMENT OF RELOCATION BENEFITS FOR TENANTS WHOSE RENTS ARE INCREASED BY 20% OR MORE IN A ONE YEAR PERIOD: This Item is pulled from the agenda at request of staff, and will be re-scheduled.

NEW BUSINESS

10. DESIGNATION OF VOTING DELEGATE AND ALTERNATE FOR ANNUAL LEAGUE OF CALIFORNIA CITIES CONFERENCE: ACTION: Appoint Abbe Land, voting delegate and Steve Schulte, voting alternate for the 1989 Annual League Conference to be held in San Francisco, October 22-25, 1989. Motion Heilman second Albert. Hearing no objection it was so ordered.

11. PROTECTION OF RESIDENTIAL NEIGHBORHOODS: THIS ITEM WAS HEARD FOLLOWING ITEM 14 (WHICH WAS HEARD AFTER ITEM 8) BUT IS LISTED HERE FOR CLARITY. Councilmember Heilman reported on this item and presented a letter from Norma Kemper, 1012 N. La Jolla Avenue, signed by 14 neighbors, regarding the problems in the area. There were also letters from Richard Schoenberg of Bonner Drive and West Hollywood West Residents Association. At this point in time the following persons came forward to address the Council:

ACTION: To approve and adopt Resolution No. 584, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD PROVIDING FOR TEMPORARY CLOSURE OF PORTIONS OF CERTAIN CITY STREETS PURSUANT TO VEHICLE CODE SECTION 21101." The City Manager and Sheriff's Department to develop implementation and procedures. Motion Heilman second Schulte. Hearing no objection it was so ordered.

Direction was given to staff to look at providing intensified foot patrol on Havenhurst/La Jolla/Santa Monica area. Councilmember Schulte asked for a follow-up report from the Sheriff's Department on the surveillance of Act-Up .LA. Councilmember Heilman suggested that staff look at applying substances or materials on walls in the La Jolla parking lot to keep people from sitting on them.

12. SPACE CONSULTANT FOR EXISTING CITY HALL: The staff report was given by Jeri Chenelle, Assistant City Manager. ACTION: 1) Approve an agreement with Michael Feerer and Associates, who are the space planners for the Civic Center, as they are already familiar with our organization; 2) Transfer \$7,500 from the Unobligated Reserve to Account 01-260-54-700, Professional Services account. Motion Heilman second Albert. Hearing no objection it was so ordered.

LEGISLATIVE

13. ORDINANCE REQUIRING PEOPLE TO CLEAN SIDEWALKS ABUTTING THEIR HOMES AND BUSINESSES: Report was given by Mayor Land. The following came forward to address the Council: Jeanne Dobrin, West Hollywood Bruce Traub, West Hollywood ACTION: To introduce on first reading Ordinance No. 241, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD REGULATING CLEANING OF SIDEWALKS AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE," and work with Public Information Office to publicize this action to the residents and business owners in West Hollywood.

14. PUBLIC SAFETY COMMISSION: THIS ITEM WAS HEARD FOLLOWING ITEM NO. 8 BUT IS LISTED HERE FOR CLARITY. Paul Brotzman, City Manager, gave the staff report, and stated that, under State law, the commission could not investigate specific complaints on individual instances, but could make recommendations to the Council concerning behavior patterns that they see in the Sheriff's Department.

At this point in time the following persons came forward to address the Council:

Councilmember Schulte proposed the following changes in the draft ordinance:

Section 2989. Duties

a through c - leave as submitted

d. add "serve as the principal citizen liaison with the Los Angeles County Sheriff's Department, the Fire Department, and other emergency service agencies;" at the end of the paragraph.

e. "serve, in conjunction with a staff person in the City Manager's office, as the city's main mechanism to establish and maintain communications with citizens relative to public safety, including processing, hearing, and monitoring trends in complaints received by the city regarding law enforcement"

f. no changes.

Delete the sunset clause but review the responsibilities, staffing and funding in one year.

Section 2990. Limitation - add "direct" the process - -.

Council requests that the Commission work on establishing a working relationship with Neighborhood Watch.

ACTION: To introduce on first reading, Ordinance No. 240, with the above changes, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD ESTABLISHING A PUBLIC SAFETY COMMISSION AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE." Motion Schulte second Koretz. Hearing no objection it was so ordered.

CLOSED SESSION: This time has been set aside for the City Council to meet in closed session to discuss matters pertaining to litigation, potential litigation, personnel, and/or claims. Mayor Land adjourned the Council to closed session at 12:56 A.M.

The City Council reconvened at 1:30 A.M. City Attorney Jenkins reported that they had discussed claims and Concerned Citizens v. City of West Hollywood, concerning Ordinance No. 236 on tonight's agenda. There will be a change made in the ordinance, so it will need to be re-introduced.

ACTION: Approve the claim of Ariel Itaev. Motion Heilman second Land. Hearing no objection it was so ordered.

15. ORDINANCE NO. 236 AND ORDINANCE NO. 236U - REGARDING REGISTRATION FEES FOR RENTAL UNITS - FOR REINTRODUCTION: The City Attorney read the following changes to be made:

Add - Section 2. Section 6411C 1 c of Chapter 4 of Article VI of the West Hollywood Municipal Code is hereby amended to read as follows:

c. Operating Expenses - Inclusions: Operating expenses shall include the following: rent increase application filing fees and vacancy increase application fees (if the application is found to be meritorious), annual registration fees which, pursuant to resolution of the City Council, cannot be passed through to tenants (which, if the application is found to be meritorious, shall be waived by the Commission), license fees, real property taxes, utility costs, insurance, management expenses - and the remaining language in the section is exactly as the section reads today in that section of the code.

There is also an additional Section 3 of the Urgency Ordinance which reads as follows:

Section 3. The annual registration fee for rental units established by the City Council in Resolution 560 is to be paid to the City by September 1st, pursuant to the Rent Stabilization regulations. In addition, the City Council also has established the amount of the fee which may be passed through to tenants residing in rental units. On August 30, 1989, a lawsuit was filed in the Superior Court, West Hollywood Concerned Citizens, et al. v. City of West Hollywood, et al., (L.A.S.C. No. WEC 139671), to prevent the City from collecting the registration fees for rental units and asserting that such fees cannot be collected until this Ordinance is effective. As a result, it has become necessary to adopt this Ordinance immediately on an urgency basis to avoid confusion in the community arising from this litigation and uncertainty regarding the law which is in effect and the lawful amount of the registration fee which is required to be In the absence of immediate effectiveness, the City paid. may be enjoined from collecting the registration fees which will preclude the City from administering the programs and information services provided by the Rent Stabilization Department which will cause further confusion and disruption in the community. It is necessary for the public health, safety and welfare that this Ordinance take effect immediately. This is an urgency ordinance and shall take effect upon adoption.

ACTION: To adopt on an urgency basis Ordinance No. 236U, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD REGARDING REGISTRATION FEES FOR RENTAL UNITS SUBJECT TO THE PROVISIONS OF THE RENT STABILIZATION ORDINANCE AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE AND DECLARING THE URGENCY THEREOF." Motion Heilman second Albert.

AYES: Albert, Heilman, Koretz, Mayor Land NOES: Schulte Motion carried.

FURTHER ACTION: To reintroduce on first reading Ordinance No. 236, as amended, "AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD REGARDING REGISTRATION FEES FOR RENTAL UNITS SUBJECT TO THE PROVISIONS OF THE RENT STABILIZATION ORDINANCE AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE." Motion Heilman second Albert.

AYES: Albert, Heilman, Koretz, Mayor Land NOES: Schulte

City Attorney Jenkins then requested that the City Council readopt Resolution No. 569 with the new Resolution No. 585, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD ESTABLISHING AN ANNUAL REGISTRATION FEE WHICH MAY BE PASSED THROUGH TO TENANTS", which is precisely the same as Resolution No. 569 that was adopted by Council on August 7, 1989, with the exception of the Resolution No., and it will contain a new Section 2 which reads as follows:

"Section 2. Resolution No. 569 is hereby rescinded and superceded".

FURTHER ACTION: To adopt Resolution No. 585, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD ESTABLISHING AN ANNUAL REGISTRATION FEE WHICH MAY BE PASSED THROUGH TO TENANTS." Motion Heilman second Albert. Noting the objection of Schulte it was so ordered.

ADJOURNMENT: The meeting was adjourned at 1:36 A.M. to a regular adjourned meeting to be held on September 18, 1989, at West Hollywood Park at 7:00 P.M.
