AND AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE" as written, the inclusion of restrictions on Doheny Drive, giving time to the people on San Vicente to obtain 50% of residents' signatures; if that is obtained they would be included in the District. Direct staff to work with the Transportation Commission to find some accommodation for the churches and schools, including the possibility of selling special church permits, and to bring this back to the Council in 30 days. Further direction to staff to expedite San Vicente as soon as the signatures are obtained. Motion Heilman second Land. AYES: Heilman, Koretz, Land, Schulte, Mayor Albert.
