- 3. TRACT MAP 46050, REVERSION TO ACREAGE, 8358 SUNSET BOULEVARD (DEVELOPMENT PERMIT 85-001): As part of the development of the St. James Club, the property is to remain as one parcel requiring the reversion of a previous sub-division. This is accomplished by the recordation of a tract map. ACTION: Approve Tract Map 46050 pending receipt of the appropriate bonds and approvals and accept the street dedication on behalf of the public. Motion Heilman second Albert. Hearing no objection it was so ordered.
- 4. APPOINTMENT TO HUMAN SERVICES COMMISSION: This time was set aside for Mayor Viterbi to make his appointment to the Human Services Commission. ACTION: To appoint Jay Greenstein to the Human Services Commission. Motion Viterbi second Schulte. Hearing no objection it was so ordered.
- 5. JOSEPH VALENTI dba VENUS PICTURE ARCADE Request for stay of execution: Mr. Norman Atkins, Attorney for Joseph Valenti, presented a request for stay of execution to a decision of the Business License Commission on February 18, 1988, for the revocation of the Venus Picture Arcade business license. ACTION: Grant the stay of execution. Motion Schulte second Viterbi. Hearing no objection it was so ordered.

CLOSED SESSION The City Council adjourned to closed session to discuss matters pertaining to potential litigation at 10:05 P.M.
