II. Board Vision/Priorities Discussion

The Board has scheduled a visioning discussion for its March 15, 2012 meeting. Input from the Transportation Committee is vital to this effort. The Board was presented with four projects for consideration when developing their priorities including: (a) the bicycle safety awareness program; (b) development of a COG-region bicycle sharing program; (c) applying for the California Energy Commission Plug-In Electric Vehicle Readiness grant; and, (d) a Transportation Summit.

III. COG Bicycle Sharing Discussion

The Board approved consideration of a COG Bicycle Sharing program. Santa Monica staff will provide leadership in this effort, which will be staffed by an ad hoc team including members of the Transportation and Sustainability Committees. An update will be provided at the February 13, 2012 meeting.

IV. Westside Cities Council of Governments Bicycle Planning Update

At the January 19, 2012 Board meeting, staff was directed to initiate a thirty-day electronic comment period to provide input on the five bicycle infrastructure gap closures recommended by staff, and return to the March 15, 2012 Board meeting with final recommendations based on input received. The recommended corridors are:

- 1. Expo Light Rail Bike Path/Bikeway (from La Brea Blvd. to western terminus of Phase 2)
- 2. Santa Monica Blvd./Broadway (from La Brea Blvd. to Ocean Ave.)
- 3. San Vicente Blvd. (from Sunset Blvd. to La Brea Blvd.)
- 4. Barrington Ave./McLaughlin Ave./Slauson Ave. (from Sunset Blvd. to the Ballona Creek Bike Path)
- 5. Beverly Dr./Beverwil Dr./Duquesne Ave./Jefferson Blvd./Overland Ave.(from San Vicente to Westfield/Culver City Transit Center)

V. Work Program Evaluation

At the December Transportation Committee meeting, staff was directed to revise the proposed Work Program to be more action-oriented in nature, and to include deliverables and deadlines. The current Work Program, and a revised draft Work Program, are included in the packet for review at the February 13, 2012 meeting
